2. Criteria for evaluation and information about the percentage weights assigned to criterion

a) The Contracting Authority will evaluate the bids based on the following criteria:

- Net price (cost) - the weight of 100%

b) The method of granting points for achieving the criterion of the offer:

- Net price (cost):

Number of points =  $(Lp / Op) * 100 * WP$  where:

- Lp - the lowest price among all evaluated tenders

- Op- the price stated in the offer study

- WP - weight price

- a) participation in the company as a partner or partnership,
- b) the possession of at least 10% of shares,
- c) the functions of a member of the supervisory or management, proxy, proxy,
- d) remaining married in consanguinity or affinity in a straight line, the second degree of kinship or affinity of the second degree in the collateral line or by adoption, guardianship or custody.
